Int position is not altogether satisfactory as regards chattels on this file. This Japanese real the Shigemeted Transfer at 268 Powell Street on rented promises and declared the following.

- (a) A number of stover and other articles belonging to different Japanese and stored with him. These are covered on the respective owners flies and have, in nearly all cases, been shipped to them.
- (b) His own effects were said to consist of a deak, a counter, four small tables and fourteen chairs, but on January 20th, 1943, we received from the Greatwood Supervisor a lone list totalling \$250.00 in value. On March 24th, 1943, we advised that we were unable to trace any of his belongings at this address. The Japanese was not satisfied with this (see his of March 30th, 1943) and it now appears that anything moved from that address may have been sold under the names of some of the other families that lived there see letter of April 22nd, 1943. For they investigations are being made but it will now be very difficult to trace this man's belongings.

The Spain wrote to Mr. SHIGHMATSH on North 22/43 advising that we had found no chattain at 260 femal St. belonging to him, and told him we assumed he had disposed of those prior to his evacuation. He replied that he had lift the goods there and sained us to investigate further. It was found that all the chattele from 200-270 Femal St. were sold in the name of Mrs. Yayene TARMOTO, File 660. We make to Mrs. Takeneyo sanding her copies of the auditor sheets, and asked her to let us know what extition credited to her belonged to SHIGHMATSH, as we believed him chattels had been sold along with here. In replying to a letter of Shigematsu, dated January 10th, 1946, we asked for more information regarding his goods, as we had no record of having anything in his name. However we have had no reply from Nim.

These six pieces in question clean out everything we have in storage for the Japanese.

Nothing has been paid on these goods since we received them in May, 1942, so you can readily see the position Shigematsu has been placed in having to store his goods through the Custodian. If we charged the going storage rates, the charges would be two dollars (\$2.00) per month which would amount to one hundred and twenty dollars (\$120.00). However we will certainly see that Shigematsu is not unduly penalized for this account as we are entirely sympathetic to the position these people are placed in.

Upon receipt of your approval and advice from Shigematsu, we will ship promptly. Thanking you, we remain
