GENERAL SUMMARY

File No. 10472. Re: Shinchiro MIZUNO - Reg.No.14404. July 6th, 1946.

Shinchiro MIZUNO made his declaration to the Custodian on June 9th, 1942. He was evacuated March 30th, 1943.

He declared that he possessed:

1. \$50.00 Victory Bond
14. \$5.00 War Savings Certificates
- a \$1500.00 Policy in the Sun Life Insurance Co., No.2297812, the beneficiary of which was his wife, Tsuru (File 10473)

None of these were brought under the control of the Custodian.


He also declared that he had an account with the Bank of Montreal, Main and Hastings Streets, Vancouver, but gave no further particulars.

The Custodian received on his behalf a refund of \$5.72 from the Provincial Collector, representing 15 Wage Deductions for first 6 months of 1941.

No other assets or liabilities are revealed on this file.
