Dear Sir As requested by you through the Department of Labour, we are forwarding our cheque in the amount of \$434.78 to the Bank of Montreal at Fort William, Ontario, to be placed to the credit of your wife, Sai Shimano. This cheque represents the entire balance of your account with the Custodian. Although you declared no household furniture in the Protected Area, it is noted from your file, that shipments were made to you, at your request. All chattels that were found in the house of your son, Aeishiro, have been credited to his account and he will receive all the proceeds from the sale of these goods, as it is impossible to identify your different family goods, left in his house.
