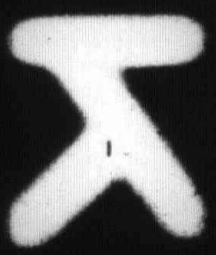

This file reveals that Mrs. TANABE owned no real property in any protected area of B.C. and did not carry any fire insurance.


CHATELS: Mrs. TANABE made her declaration to the Custodian on June 9/42 and was evacuated on Sept. 9/42. She declared chattels as shown on the Chattel Schedule on file, at 128 W. 4th Ave. This property was owned by Mr. S. MURATA. It included 128-130 W. 4th Ave. Goods removed from this address were not clearly marked with the names of the owners and the bulk of the proceeds from sale of these chattels was put into Chattel Suspens account until the owners could be identified. The files of all those who left chattels at this address have been reviewed and the chattels divided as well as possible in accordance with their respective declarations. The only article declared by Mrs. TANABE and not found by the Custodian is one small table. The balance of the chattels were sold at auction for the net sum of \$9.35 and this sum credited to her account with the Custodian.

No property interests other than those mentioned above are found on this file.
