This file reveals that Mrs. TANAKA owned no real property in any protected area of B.C. and did not carry any fire Insurance.

CHATTELS: Mrs. TANAKA made her declaration to the Custodian on June 9/42 and was evacuated on Sept. 9/42. She declared chattels as shown on Chattel Schedule on file at 128 West 4th Ave. A number of people lived at this address which was omned by Mr. S. MURATA. Their goods were not clearly marked with the names of the owners. Consequently when the goods were removed to auction it was impossible to accurately identify the goods, so the bulk of proceeds from their sale was put into Chattel Suspense Account This has now been divided as well as possible between the tenants of this address in accordance with their respective declarations. It will be noted that all chattels declared by Mrs. TANAKA have been accounted for with the exception of a double bed and a child's bed. There is a memo on file 12501 which states that 5 beds in all were discarded from this address it is possible that her beds were among those discarded.
