From your file we observe that there is a claim of \$99.98 by Toshiaki Sumi, Reg. No. 07918, at Tashme, B. C. and we should be glad to know if you acknowledge this debt and what prospects there are of your repaying same.

We also see from your file that there is a claim of \$10.29 against you dated March 18th, 1943 by the B. C. Telephone Company for L. D. Tolls for the month of June 20th, 1942. Please also advise if you admit this debt and if so, what arrangements can you make to pay same? As these are the only two claims on your file, we would like a prompt reply to this letter whether you are in a position to make payment or not and to this end a stamped addressed envelope is enclosed.
