PERISONAL PROPERTY STIMMARY File No. 10512 August 21, 1946. High suce Shie Reg. 10, 20960 This man signed a declaration to the Custodian on June 9, 1942 in which he reported that he owned no property of any kind in the protected However, on June 9, 1942 he requested shipment of 19 pieces of effects declared by his wife. Lacking evidence to the contrary we assume these were shipped to him. The records of the Japanese Fishing Vessels Disposal Committee show that this man was the owner of a vessel released to the Canadian Fishing Co. licensed owners. On July 20, 1942 we received the sum of \$110.00 from the Canadian Fishing Co. in payment of SAKAL's equity in the vessel. The account of this man was credited with the sum of \$50.25 received as refund of expenses incurred at the time of the impounding of his vessel. On July 27, 1942 we remitted \$100.00 to SAKAI. We are today transferring the balance standing to his credit with this office \$60.25 to T. Maikawa Stores to be applied on a claim filed by that company against SAKAI, which debt Sakal admitted in a letter written July 7, 1945. This file reveals no other property of any kind. This summary is certified to be in accordance with information on file. Mulwan August 21, 1946.
