Re: Estate of Paul Hasegawa

Our records indicate that Seichi (known as Paul) Hasegawa, student, age 20 in 1942, was evacuated on June 30, 1942, to East Lillooet, B. C. As far as we are aware, this man owned neither real nor personal property in the Protected Area of British Columbia, other than Sun Life Insurance Policy No. 2172088 for \$1000.00, the beneficiary being his mother, Hana. He also stated to the Custodian that he had a Safety Deposit Box No. 198 in the Westminster Trust Company, 713 Columbia Street, New Westminster. Neither the Life Insurance Policy nor the Safety Deposit Box were taken under the control of the Custodian.

With reference to any property which he might have acquired in or near Lillooet, since this area was outside the Protected Area of British Columbia as outlined by Order in Council in 1942, any such property did not vest in the Custodian and we have no record of it. We may say that we have not been informed of the death of this man and have no knowledge concerning his estate other than mentioned above.

We understand that it is possible for you to obtain the names of this man's relatives from the Department of Labour, Japanese Division, 52 Commerce Building, Vancouver, B. C. Seichi Hasegawa's R. C. M. P. registration number was 08612.
