No. 01739 On examination of File \$679 we find that no chattels were declared by Asskichi MAKAMURA but his wife did declare a number of chattels. There is also evidence on the file that four other Japanese had belongings in 2342 Rton Street, owned by MAKAMURA. Their names are: Yosaka HORIUCHI - New Denver, B.C. rolate Torint, Steem 6 to B.C. Powell Lumber & Fuel Co. Ltd. McGillivrey Palls, B.C. We also find that Mr. MAKAMURA was given permission to come to Vannouver and sort out his chattels and that of the other people mentioned above and corroborated by Mr. Spain's senorandum of November 18th, 1943 on file 679 also memorandum of Dec. 2/43. This would appear to dispose of these chattels. Chartels that remained at 2342 Bton St. after Mr. MARANURA had left, were sold at Ametion and by private sale and credited to his account on our books.
