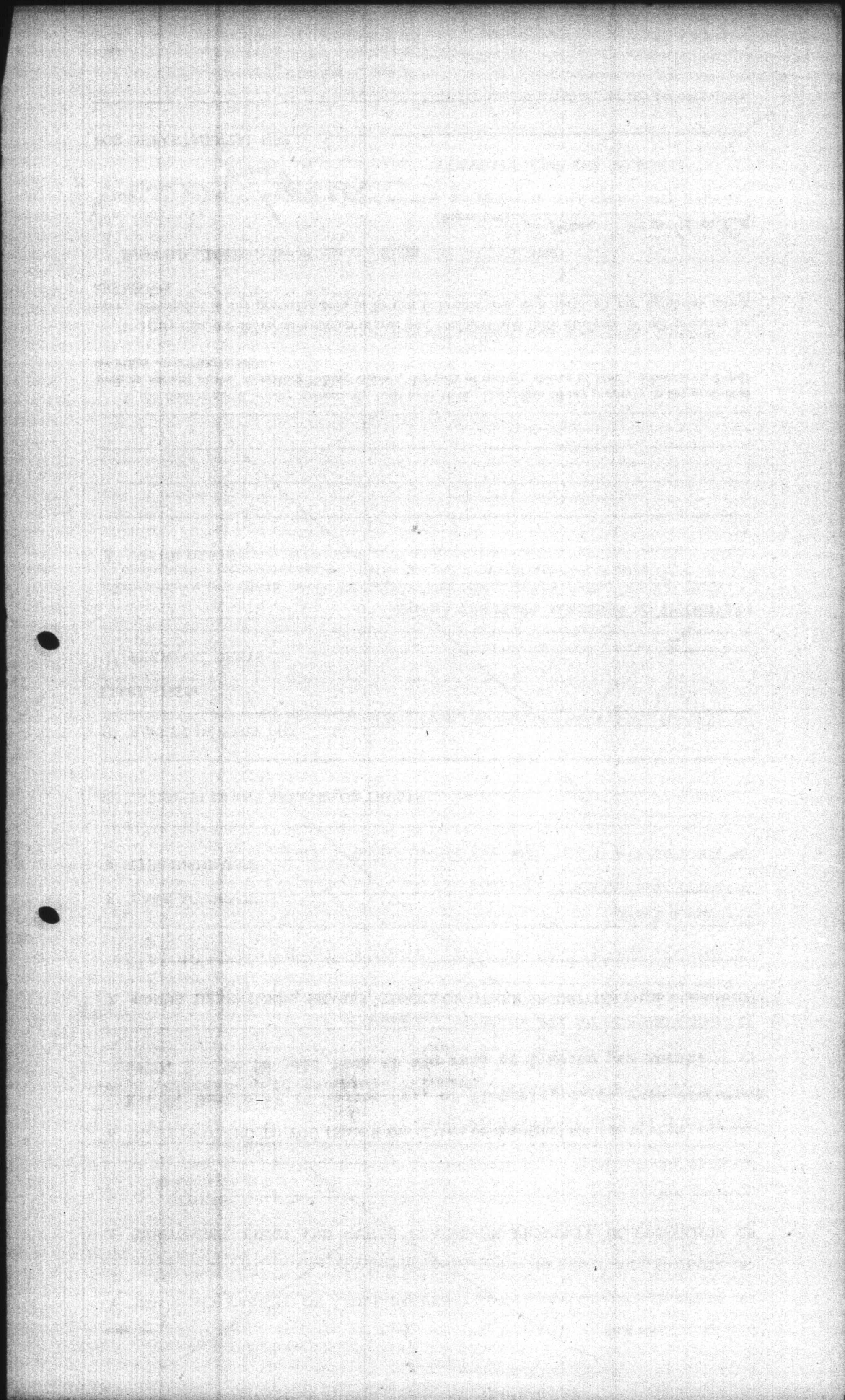

Haru NAKATA died at Essondale Mental Hospital on March 30, 1945. According to information on file, he was a widower and had no living relatives.

The only asset declared by the deceased was a debt of \$400.00 owing to him by a Mr. B. Henton, Victoria. No information is available as to whether or not this was paid.

The only claim on file against the deceased is for the sum \$57.20, being funeral expenses paid by the B. C. Security Commission. They were advised on April 11, 1945, that no funds were available from which to pay the claim.
