

Tatsuro SUGIMAN says in his declaration that 249 Princess Avenue is rented by his father, Iwazo, who in turn says in his declaration that the landlord of 249 Princess Avenue is a "Mr. Tamborin?". Mrs. Iwazo lives at 249 Princess Avenue, but her file contains nothing at this date except a registration card.
