MEMORANDUM - MRS. McARTHUR



Real Estate in Vancouver is owned by Mr. and Mrs. Fujiwara jointly. Please transfer contents of file No. 13296 to our Enemy Department so that they may protect their enemy's interest.

File No. 10879 covers Kikuye ISOSHIMA who resides in Bridge River presumably as the common law wife of Mr. Fujiwara, but Kikuye ISOSHIMA has no interest in or equity in relative real estate in Vancouver and she is not to be credited with any portion of rent income. Please advise the Accounting Department accordingly so that they may make the necessary corrections.

Please also have transferred from file No. 10879 corresponding rental statements.
