359 " " (centre upstairs)	7.00

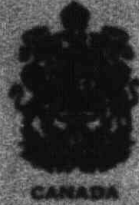
Store at 359 Powell St. was rented for two months for \$25.00, but is now vacant, but a new tenant is going in on March 15th.

We have had to install a bath at 238 Main Street at a cost of \$57.50.

At the present time we have a credit balance of \$355.55 to Mrs. Yamamoto's credit, but the 1942 taxes amounting to \$485.38 have not been paid. In addition the Japan and Canada Trust Savings Co. hold a Mortgage against these properties for \$19,958, and have received
