



Re: Ihachi and Hanan MIYASAKI and  
Crown Life Insurance Policy #1060730

On August 2nd, 1946, the above policy holder, his wife and two minor children returned to Japan. They left with us for safe keeping the above policy which is fully paid up and has an approximate value of \$2,160.--.

As they did not turn in any cash at the time they requested to go back to Japan they were advanced the basic amount of \$200.-- for each adult and \$50.-- for each child, making a total of \$500.--. We only have a credit of \$3.-- odd in his account.

What position should we take in regard to this and any similar matters? Order-in-Council P.C. 7355 speaks of real and personal property which has not been sold or otherwise disposed of prior to departure is vested in the Custodian for the purpose of liquidation.

Is it the intention that life insurance interests should be dealt with by the Custodian and the cash surrender or maturity value of the policy be obtained, irrespective of the wishes of the policy owner, in order that the Department of Labour may be re-insured for the advance which they have made.
