Door Sires Isoriro KARITOMA Replying to yours of the 20th uit. re the above, we did not reply to yours of the 19th of Pobruary sooner because we have only located the individual against whom you have a claim. We have been making enquiries from numerous sources, and have only now been able to locate him through the Statistical Division of the Provincial Board of Health, who inform us that HAMITOMA died on the Sth of October, 1940. We quote from their letters "The decembed formerly lived at 2054 Dundas St., Vancouver, a farmer by occupation, aged forty-eight years, eleven months, and the cause of death was Pulmonary Tuberdulosis. Dr. G. R. Dorrett attended the deceased; the informent being his son, H. Kamitomo of 2054 Dundes St., Vancouver." We have written to his wife, Mrs. Hide KAMITOMO and forwarded your claim. We are afraid, however, that the chances of your collecting are very remote, for as far as this office is evere his family have no assets and there is approximptely \$600.00 owing by the estate.
