#### NOTE TO THE FIRE

June 11, 1942.

Mr. Maddaford of P. C. Gibbens, telephoned this morning to report that Mrs. N. Okuno, 575 East Hastings, owner of the Carl Rooms, has sold her property for \$3,000., had received \$2,000. in cash and promissory notes for the balance of \$1,000. Further, Mr. Maddaford reported that he had been requested by Mrs. Okuno to par discount on the said promissory notes.

I informed him that as Mrs. Okuno had not registered her property with us and that in view of the fact that she had not been evacuated, the Custodian's office was in no way involved.

Mr. Maddaford said that when Mrs. Okuno calls this afternoon he would ask her for her police registration card and should he find that said card was endorsed by the Custodian's office he would get in touch with us by telephone before taking further action.
