However, the file reveals that the fishing vessel, "Royal K"/"T.K." was sold on April 29, 1943 through the Japanese Fishing Vessel Disposal Committee for the sum of \$1,050.00. The funds were credited to the licensed owner, Takeo KAWASAKI, on May 2, 1942.
