MEMORANDUM TO FILES

File Nos: 11217, 11585, 11586, 11587 and 11588

There has been some confusion over chattels on these files and correspondence is filed haphazardly.

My memo of September 21st to Mr. Spain, though marked for all five files, does not appear on File 11217. Since it was written there was filed on 11587 a list of goods moved to storage under date of August 8th, 1942. A copy of this, though marked for all five files, appears on File 11588, -4.

Subsequently Mr. Spain apparently wrote to one of the sisters though no letter appears on the file. A reply was received on October 27th on File 11587 from Itoko. She draws attention to Mrs. Aoyama's additional registration, points out that the articles declared are jointly owned by the four unmarried sisters and claims some missing articles.

The present position is fairly well summarized in our letter of November 13th on Mrs. Aoyama's file, 11217. This enumerates the following:

- A. Missing articles.
- B. Items moved to storage at 992 Powell Street.
- C. Kitchen cupboard, stove (and according to agent's report, linoleum) left at 516 Alexander Street. The bailiffs found nothing of value here, but a check is being made.

Finally Messrs. Ker & Ker reported on 11585 and 11586 that there were 4 small cartons or packages, contents unknown, in an upstairs room. Their report covers both 516 and 518 Alexander Street and it is not clear at which address these packages were left. As both premises were rented to tenants who had to be evicted for non-payment of rent, it seems most improbable that these are still there, if indeed they were not removed by one of the sisters before evacuation. However, a check of this is also being made.

Remarks: These premises were in the hands of Ker & Ker Ltd., Agents, for supervision and the collection of rentals. They reported at length as of July 22, 1942. In this report they describe the property as "an old style property" with Building set in the rear of the lot. Prior to evacuation Mrs. AOYAMA, the owner, rented the premises to a Mr. and Mrs. A. Petrie at \$25.00 per month as from July 14th, 1942 and they paid Mrs. AOYAMA \$12.50, being the rent to July 31st, 1942. The owner had removed the blinds to storage and the tenants complained of this. From the very beginning of the administration trouble was the main feature of the rental arrangement, and the file is largely composed of efforts to collect rent from the Petrie and the maintenance of the property in a habitable condition. Arrears of rent eventually required that the matter be placed with Locke, Lane, Guild & Sheppard, Barristers, who on Sept. 7, 1944 issued an Eviction order to get rid of the Petries. It appears however that before the eviction order was executed, the Petries moved to White Rock as noted in letter Sept 30, 1944-Ker & Ker Ltd.- leaving the house vacant and owing according to rental statement the sum of \$202.50. This has not been collected. The property was then boarded up, as per letter Oct. 6, 1944- Ker & Ker, Ltd. and was not again rented while



"Prudential Life Insurance Co. 510 Hastings St. Vancouver, B.C. 10¢ per week per child - 5 children. Policy No. unknown. Benef. (Tomiko) mother. Paid to date. 20 year endowment. Policy in declarant's possession".

Usually in cases of Life Insurance as it does not vest in the Custodian this office does not take any action in respect to same. However, in the present instance it seems that this office was asked to look after the payment of Insurance premiums if, and when funds were on hand belonging to Mrs. AOYAMA from rentals of 516 Alexander Street. A memo dated Sept. 22, 1942 on file, point to this arrangement.

Reference is also made to Memo March 15th, 1945 by A.G.M. in respect to this same situation. Later reference is indicated in a letter from Prudential Insurance Co. of America of June 8, 1945 with enclosure. No further action by this office appears after that date.

ACCOUNTS RECEIVABLE:

In her supplementary registration dated Sept. 21, 1942 Mrs. AOYAMA indicates the following sums as owing to her:-

I should write to you & let you know why I have not paid Mrs Aoyama. owner of above premises any money she claims I owe her. I took over the house ^{15th July} as it was the middle of July. I thought I would be fair in paying the half month phone bill. and she also sold me some wood & small amount of coal. Now when the next rent became due ~~at~~ the beginning of August. The agent came & told me I was not to pay any rent to the owner but that they would collect the rent. Well Mrs Aoyama was quarantined at Hastings Pk and she got somebody there to phone me and ask me to pay the next phone bill

and as I did not want to keep the phone under a Japanese name I told her I could not pay it. (And I think I was justified in not wanting to keep the phone under their name.) However a sister of the owner came & told me that she had paid two months phone bill as they did not want the phone taken out. I resented this as I figured that I was paying rent and wanted nothing in the house under the name of "Ooyama". However I did not think it was up to me to pay this phone. However I thought that when I moved in the house the Japs would have nothing more to do with it. But to my bitter resentment I have had them here

With regard to the above property, we beg to report as follows: As you know, this property was rented to Mr. Petrie by the Japanese. Upon making our first report we found the rent was in arrears and at that time we received certain promises from the tenant as to the payment of these arrears.

The writer visited the property personally on several occasions but found that due to sickness and unemployment these people could not make a payment on the current rent or the rental arrears.

Acting upon your instructions we turned this matter over to Thompson and Birmingham, the bailiffs, on January 9th, but they stated that there was nothing in the house of any value that they could seize. We subsequently contacted your office in this connection and received your instructions on the 12th of January to have this tenant evicted for non-payment of rent. It was found that the services of a Lawyer would be required to carry out this action and we, after consulting your office, turned this matter back to you for your attention.

We were then instructed to endeavour to collect the rent in an amicable way. The writer again visited the property on Saturday morning of the past week and found that Mr. Petrie was in bed awaiting his turn at the hospital to undergo an operation. One boy in the family is working but evidently only makes enough money to buy groceries.

While we see no immediate prospect of obtaining the rent, we believe that this particular family will pay the rental arrears as soon as Mr. Petrie is in a financial position to do so.

We will keep in touch with this particular property on your behalf.

Dear Madam:-

We have brought forward your file for review and to examine your affairs that have come under our control preparatory to making a brief report to you at this time.

In this review it is noted that you were the owner of 516 Alexander Street, Vancouver, B.C., and that this property was your principal asset here. These premises were rented by you to a Mr. and Mrs. Petrie at \$25.00 per month. Messrs. Ker & Ker, Ltd., Agents, had supervision of same reporting to this office from time to time. From the very beginning we had considerable trouble with the tenants, as you will remember, eventually requiring an eviction order to obtain possession of the premises. They left owing considerable rent which it was not possible to collect.

This property was sold on October 16th, 1944 and the sale was reported to you. In February 1945 we sent you a General statement of your account from the beginning and showing a credit balance of \$1109.49 also a statement showing particulars of sale of 516 Alexander Street, which amount was included in General statement. The General statement showed the revenue received and credited to your account up to the date of sale.

We have now prepared, and are enclosing a further General Statement showing a credit balance of \$765.00 here for your account. *✓ forward on file*

In regard to the Household Furniture and personal effects, in which you were interested, we may say that it has been very difficult, if not impossible, to clarify the situation in respect to those belonging to you and those belonging to your four sisters. Our file indicates that there was difficulty from the very beginning. However, a small number of items were sold, the net proceeds of which amounted to \$52.20, which amount is on hand in the account of Tomako DESHIMA pending decision amongst you five sisters as to the distribution of this sum. We propose to prepare a list of articles showing how this amount is arrived at, and by separate letter to each of you, ask that you agree on the distribution so that we can pay out this sum to the proper persons. In addition to \$52.20 will be added a kitchen range sold for \$9.00 net, which amount appears in your personal account.

In the attached statement you will observe that several accounts were paid and charged to your account. This action on our part was authorized by you.
