Chattels: Mrs. Murata declared a list of chattels at 1726 W. 2nd Avenue, Vancouver, B. C., these to be rented with the house when they evacuated. As real property was registered in the husband's name and he also declared the above mentioned chattels, the administration of both real and personal property was conducted on the husband's file (11594).

Life Insurance;

The above Evacues declared a \$1000.00 Monarch Life Assurance Go. policy Bo. 93763 in the name of her husband. However, the husband's declaration reveals that this policy is for \$200.00, and his file shows that he received the cash surrender value of the policy in July 1943.

Also declared on Mrs. Murata's JP form are to Prudential Life Insurance policies, Nos. 110952405 and 110952407, in the names of Toyoko and Masuo, respectively. Beneficiary, Mother - Miyako Murata. On July 12/43 we were informed by The Prudential Insurance Company of America that Mrs. Murata had requested the cash surrender value of the above policies. Accordingly a cheque was sent to us through the Prudential Insurance Company for forwarding to Mrs. Murata. We mailed the cheque for \$106.41, total surrender value of the two policies, to Mrs. Murata on August 3, 1943.
