
Please note that the above has been repatriated to Japan. At the time of repatriation, the following transactions took place:

SUMMARY OF LIABILITIES

No debts were declared by the above Japanese person on his Form J card dated August 24, 1942, but a review of this file reveals a claim of \$3.50 against the above by Dr. H. Uchida and a claim of \$500.00 by Taichi SAENISHI. At a later date Dr. Uchida withdrew his claim of \$3.50.

On writing to Mr. Nukuda regarding the claim of \$500.00 he replied on June 28, 1943, stating he did not remember about the \$500.00 and was not going to pay it. He advised the creditor accordingly and gave him the address of Mr. Nukuda so that he could contact him direct if he so wished. We also wrote to Mr. Nukuda informing him that we had advised Taichi Sakanishi of what he had said in his letter.

No further action regarding the above claim taken by Custodian.
