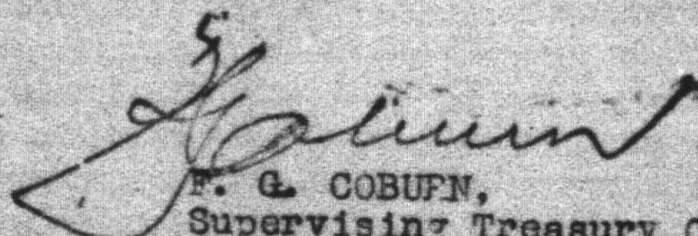

MEMORANDUM

TO: MR. F. G. SHEARS

Re: Reiko Kimura, Registration No. 15768,
Deceased.

We were advised by the Department of Labour on April 10, 1948, that Reiko Kimura died in Ontario without funds and without friends and asking if this office had any funds to his credit which might be applied against the funeral expenses.

The only asset of the deceased of which we have knowledge is a Western Mutual Benefit Association Certificate No. B 589/589 in the sum of \$500.00. This Certificate has been removed from safekeeping and it is found that the beneficiary named is Yoshie Yamasura who returned to Japan on August 2, 1946, and who owes the Treasury Department the sum of \$347.54.

Should steps be taken by this office to collect the death benefits under the Western Mutual Benefit Association Certificate on behalf of Yoshie Yamasura and so obtain funds to cover his indebtedness to the Treasury Department.

It will not be possible to pay the funeral costs from the insurance but, by the time Succession Duties are paid, it is not likely that there will be more than sufficient to pay the debt to the Treasury Department.
