This 61-year old Japanese National Logger, a widower, from Indian River, B. C., signed a Custodian "JP" declaration form on the 14th July, 1942. He was evacuated on the 27th August, 1942, and repatriated to Japan, per S.S. "Marine Angel", on May 31st, 1946.


