A Custodian's release form dated August 7th, 1943 signed by Mikie TAHARA requests that one Singer Sewing Machine be forwarded to her at Tachme, B.C. Apparently this was done August 19th, 1943 as per receipt of Dept. of Labour, Japanese Division. Her file does not otherwise reveal that she had a Sewing Machine. However her husband's file # 14815 records the ownership of a sewing machine. As the J.P. form on that file is apparently signed by Mikie TAHARA the release of the machine per file 11455 has been regarded as in order.

No other Assets are revealed on the file.

LIABILITIES:

A Claim for \$4.50 by Dr. UCHIDA against Mikie TAHARA is revealed on the file. However Dr. UCHIDA withdrew all claims per his general letter of August 3rd, 1943.

No other Claims against or indebtedness of Mikie TAHARA are revealed on the file.
