This file reveals that Mrs. NISHIRATA owned no real property in any protected area of B.C. and did not carry any fire insurance.

One chest of drawers was shipped to husband Nov. 10/44.
The plane was shipped on or about September 30/43.
We gave Mrs. NISHIHATA permission to make her own arrangements regarding shipment of her radio.
