GENERAL SUMMARY

RE: Mitsu SAITO, Reg. No. 08305

Mitsu SAITO made her declaration to the Custodian on July 16/42 and was evacuated on July 25/42. She declared only a savings account with the Canadian Bank of Commerce, Kitilano Branch in the sum of \$95.00. On Jan. 23/45 we sent her an advice received from this bank stating that she had a balance of \$99.56 in her account with them. This was not brought under the control of the Custodian.


Although she declared no life insurance, we received from the Sun Life Assurance Co. a cheque in the sum of \$1,286.22, in favour of Mitsu SAITO. This cheque was in full settlement of all claims under Supplementary Contract No. 2,199,581. We sent this cheque to Miss SAITO on June 6/46.

No property interests other than those mentioned above are found on this file.

The above summary is certified to be in accordance with the information on file.
