Hidekazo SAITO made his declaration to the Custodian on July 16/42 and was evacuated on July 25/42. He declared a savings account in the Fairview Branch of the Royal Bank of Canada in the sum of \$119.84. This was not brought under the control of the Custodian.

We received from the Sun Life Assurance Co. a cheque in the sum of \$1213.63 in favour of Hidekazo SAITO, being the maturity value of policy #2199585. This cheque was resitted to SAITO on Sept. 29/44.

No property interests other than those mentioned above are found on this file.
