PERSONAL PROPERTY SUMMARY

This file reveals that Mrs. KURITA owned no real property in any protected area of B. C. and did not carry any Fire Insurance.

CHATELS: Mrs. KURITA made her declaration to the Custodian on July 16/42 and was evacuated on Oct. 15/42. She declared the following chattels:

5 linoleum carpets	1 long cutting table
2 double beds with springs & mattresses	1 kitchen stove
1 single bed " " " "	1 wood heater
10 kitchen chairs	kitchen cabinet
2 tables	one 2 ring gas stove
	1 chest of drawers.

She stated these would be left at 321 Hawkes Ave. and that Mr. Dean of 1665 W. 11th Ave. would have the key. She also said she would try to sell these prior to her evacuation.

We wrote to Mr. Hawkes about these goods on June 18/43 and he advised that no chattels whatsoever were left in the house.

In a letter dated Nov. 24/44 Mrs. KURITA advised that she had left certain chattels at 746 Cordova St. in care of Mr. Yuhei MATSUGU. Mrs. KURITA's goods had been sold along with those of another Japanese with chattels of Mr. MATSUGU. Mrs. KURITA and Mr. MATSUGU agreed between themselves after seeing the auction sheets, which goods belonged to Mrs. KURITA and these were accordingly transferred to her account. The net amount was \$2.66 and this sum was remitted to her on Jan. 24/45.

INSURANCE:

She declared a policy with the New York Life Insurance Co. The maturity value of this policy in the sum of \$10.00 was sent to this office by the Company on July 27/44 and remitted to Mrs. KURITA on July 29/44.

No property interests other than those mentioned above are found on this file.



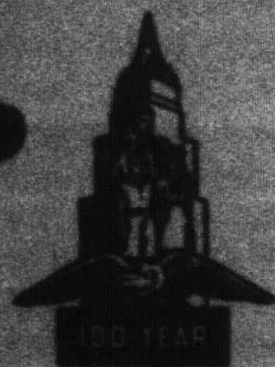
