This file reveals that Mrs. MURITA owned no real property in any protected area of B. C. and did not carry any Fire Insurance.

Mrs. KURITA made her declaration to the Custodian on July 16442 and wa CHATTELS: evacuated on Oct. 15/42. She declared the following chattels:

5 linoleum carpets

2 double beds with springs & mattresses

l single bed

10 kitchen chairs

2 tables

1 long cutting table

1 kitchen stove

1 wood heater

kitchen cabinet

one 2 ring gas stove

1 chest of drawers.

She stated these would be left at 321 Hawkes Ave. and that Mr. Dean of 1665 W. 11th Ave. would have the key. She also said she would try to sell these prior to her evacuation.

We wrote to ar. Hawkes about these goods on June 18/43 and he advised that no chattels whatsoever were left in the house.

In a letter dated Nov. 24/44 Mrs. KURITA advised that she had left certain chattels at 746 Cordova St. in care of Mr. Tuhei MATSUGU. Mrs. KURITA's goods had been sold along with those of another Japanese with chattels of Ar. MATSUGU. Mrs. KURITA and Ar. MATSUGU agreed between themselves after seeing the auction sheets, which goods belong to are. KURITA and these were accordingly transferred to her account. The mt amount was \$2.66 and this sum was remitted to her on Jan. 24/45.
