
Please note that the above has been repatriated to Japan. At the time of repatriation, the following transactions took place:

The following claims against Masajiro SHISHIDO are revealed on the file:-


1. Komura Bros - \$16.76

Item 1. Komura Bros. This claim was submitted to Masajiro SHISHIDO but no reply was received. Our letter of January 22nd, 1944 again drew attention to it but no answer is indicated by the file. The Creditor is being advised today that we have not been successful in collecting the account and that he is listed for repatriation on one of the first boats.

Item 2. Dr. UCHIDA. This claim was withdrawn by General letter of Dr. UCHIDA dated August 3, 1943.

No other claims against or indebtedness of Masajiro SHISHIDO are revealed on the file.
