This file reveals that Matsumosuke SHIBUYA owned no real property in any protected area of B.C. and did not carry any Fire Insurance.

CHATELS: SHIBUYA made his declaration to the Custodian on July 20/42 and was evacuated on March 12/42. He declared no chattels and none were found by the Custodian belonging to him.

MONEYS On April 14/43 his account was credited with the sum of \$6.94, being a RECEIVABLE: refund of 1% wage deductions for first six months of 1941. This is his only credit with the Custodian.
