Life Insurance: The above Evacuee had two insurance policies, one with the Prudential Insurance Company, Policy No. 107319871, and one with the Monarch Life Assurance Company, Policy No. 102423.

On July 7, 1943 The Prudential Life Insurance Company wrote to us advising that Mr. Ono had requested the cash surrender value of his policy, which amounted to \$43.61. They forwarded a cheque for this amount to us on July 29, 1943, which we in turn sent on to Mr. Ono on August 3, 1943.

Mr. Ono also requested the Cash Surrender Value of his Monarch Life policy in October, 1943, which amounted to \$91.20. The Monarch Life sent a cheque for this amount to the Custodian and we forwarded it to the above Evacuee on October 26, 1943.
