Shotaro OYAMA died at Grand Forks on February 3, 1943. He was single, and according to the information supplied by the B. G. Security Commission at the time of his death, he was Survived by his nother, Tsume, file #7436, and two brothers, Massharu, file # 2801, and Massamitou, file #2822.

The deceased declared no assets to the Custodian but in a copy of his will, translated from the Japanese, forwarded to this office by the B. C. Security Commission on March 2, 1943, he bequeathed his motion picture projector, attachments and films, to his brother, Massmitsu. As this projector was taken by Shotaro Oyana outside the Protected Area, this machine was not vested in the Custodian. Therefore, there were no assets belonging to the deceased, of which we have knowledge, which come under the control of the Custodian.

Claims were filed against the deceased as follows:

The creditors were advised of the state of Dyama's affairs and that this office had suggested to Tsuma OYAMA, mother of the deceased, that she apply for probate of the will. The claim of Dr. Uchida was later withdrawn.
