
On July 21, 1942 the above Evacuee signed our Form J card declaring that he had no liabilities, but on reviewing his file the following claims against him are revealed:

Dr. M. Uchida	-	\$20.00
Mrs. Yoshiko (Yoshikumi) ABACHI		50.00
Toshiaki SUMI	-	130.00
Dr. Hori	-	100.00

Our Claims Department advised the above Evacuee of these claims on March 1st, 1943, but in the absence of any reply we advised the creditors that no further action was being taken by the Custodian as Mr. Teshima had no funds with this office and he declared no assets. At the same time we gave each of the creditors, with the exception of Dr. M. Uchida, this Evacuee's address that they might contact him direct. Dr. M. Uchida withdrew his claim of \$20.00.

NO FURTHER ACTION REGARDING THE CLAIMS AGAINST THE ABOVE JAPANESE PERSON IS BEING TAKEN BY THE CUSTODIAN.


