The account of this man was credited with the sum of \$4.77 received as refund of 15 wage deduction for 1941.

The Metropolitan Life Insurance Co. informed us that they carry a policy on the life of this man's son, aged 6 or 7. This did not come under the control of this office.

Drs. Bissett, Watson, McHaffie & Beever-Potts filed a claim for \$15.00 against this man. This does not appear to have been referred to YAMADA and we are doing so today.


