Re: 133 West 5th Avenue

On file 11600 under date of August 17th, ¹⁹⁴³ appears a manuscript list of effects to be looked after by Mrs. Conte for the duration of the war. These belong to Mr. Shinjiro KITAGAWA, Mrs. Eiko MARUMO, and Mrs. Akiko IRIE.

¹⁹⁴³ Under date of February 18th, there appears on file a copy of a letter to Mrs. Conte asking for the shipment of one or two items.

Reference to Mrs. Akiko IRIE's file 11591, shows no chattels declared by her. Mrs. Eiko MARUMO, file 11613, declares a number of items at 133 West 5th Avenue which, together with others, are inventoried as per memorandum of January 6th on that file. This inventory does not agree with the list dated August 17th on file 11600 referred to above, but as the former is signed by the tenants, it must presumably be taken as correct. Further investigation may be made at the time the sale of this property is concluded.
