GENERAL SUMMARY

December 21st, 1945

Re: Mr. Masa MATSUMOTO
Reg. No. 01216.

No real or personal property was declared by the above Japanese person on his JP form dated March 17, 1943, and in a letter on file dated March 15, 1943, Mr. Matsumoto states he has no property whatsoever in the Protected Area.

However, under date of March 25th, 1944 there is a footnote on the Claims Sheet stating that the above Evacuee has a credit balance of \$423.46 in the Royal Bank of Canada, East End Branch, Vancouver. No action regarding this money was taken by the Custodian.

A review of this file confirms Matsumoto's declaration, namely, that he has no property of any kind whatsoever in the Protected Area.


