I agree this claim is correct, but at present I have not the funds to give you a cheque in settlement. The amount of \$700.00 that I owe to Mr. Hayashi is the balance of the wages of which he worked at my wholesale "Coast Growers Produce". I had an understanding with him being very good friends, I could repay him when I had enough funds to carry on with my own business. But this war and the evacuation made all the troubles for me. When peace time comes I will repay Mr. Hayashi as soon as I can, and I'm sure that Mr. Hayashi will agree with this and understand the whole situation. So please do not both with the case any more. I cannot pay the money for the duration of the war, cause we are just barely making our own living here in Alberta.

I have answered your letter of December 29th, 1942, long ago, you should have received it before February 4th, 1943, if I'm correct.

I hope I have given you the correct and full information regarding the case. If not write to me again and I will give you as much information as I can.

Dear Sirs:

The amount \$1742.32 is the list of debtors of Coast Growers Produce Co. all money owing to this company and also the sum of \$735.61 Hanjiro Yoshijima is the money the company owes to Mr. Yoshijima on vegetable produce.

The sum \$700.00 (Shinichi Hayashi) is my personal debts I owe him this money. The Coast Growers Produce Co. took out the license under two people Genshichi and Takejiro Takahashi on April 1940, but Takejiro Takahashi left the firm in November of 1941. When we had to close the firm I was the only owner.
