Re: CHATTEL

According to the registration, this woman declares furniture owned jointly with her Internec husband.

Mr. D. A. Smith visited the premises and made a physical check up and found the place locked and inaccessible. The name of the house owner is unknown, nor is there any indication as to the building of the agent's name. A further search of records will be necessary to gain access to this place to make a physical check up.

Mrs. Shimizu is in the Immigration Building and will remain there for an indefinite period. As it is practically impossible to extract any information from her on the subject, we will have to try to gain the necessary information in some other direction.
