Dear Sir:

Enclosed herewith is Custodian cheque in the amount of \$69.57, representing all the funds standing to your credit with this office.

Your file in this office has been reviewed, and it is noted that you declared ownership of no chattels. Your wife, however, did declare quite a large quantity of chattels, and of these there remains in the protected area the shoe repair machine and tools about which we wrote yourself and Mrs. Kato on October 31st. These chattels, having been declared by Mrs. Kato, are being regarded as her property and are dealt with in her file.

The refund of one per cent wage deductions, which was received by the Custodian on your behalf from the Provincial Government in the amount of \$7.85, was remitted to you by Custodian cheque on February 22, 1943.

Sun Life Assurance Company cheque for the sum of \$640.00 was mailed to you from this office on August 17, 1944. This cheque represented full settlement of all claims under your life policy #2031263.

Your share of the final distribution of assets of the Royston Savings Association, on the basis of your 25 shares, amounted to \$87.53. From this there was deducted the sum of \$17.96 to settle principal and interest on the loan made to you. This left a balance of \$69.57 which was credited to your account, and which is being remitted to you by the enclosed cheque.

It would appear that we have accounted for all the property of every kind left by you in the protected area which vested in the Custodian and in order that you may confirm this and acknowledge the enclosed cheque, we are attaching hereto a stamped, addressed envelope for your convenience in replying.

This man was evacuated on March 15, 1942. He signed a declaration to the Custodian on June 23, 1942.

- Chattels: He declared no chattels. The chattels referred to in letter from Mr. R. G. Bell, October 31, 1942, were declared by Kikuye KATO, File 4016, wife of Guntaro KATO, and these are dealt with in her file.
- Life Insurance: Sun Life Assurance Policy #2031263, in the amount of \$2,000.00. On August 17, 1944, the Sun Life Assurance Co. of Canada sent to this office a cheque for \$640.00, representing the settlement of all claims under this policy. This cheque was mailed to Guntaro KATO from this office the same day.
- Accounts Receivable: Refund of 1% wage deductions for first six months of 1941 was received in this office from the Provincial Government, in the amount of \$7.85, and this sum was credited to this man's account and remitted to him on February 22, 1943.
- Shares: Royston Savings Association - 25 Shares. The 25 Share Certificates have been placed on this file. This man's account has been credited with the sum of \$69.57, representing proportionate share of assets, in the amount of \$87.53, less loan and interest in the amount of \$17.96.
- Motor-car: Our motor-vehicle records reveal no motor-car owned by this man as having been surrendered to the authorities or sold by the Custodian.

This file reveals no other property of any kind whatsoever.
