Dear Sirt Enclosed herewith is Custodian cheque in the amount of \$69.57, representing all the funds standing to your credit with this office. Your file in this office has been reviewed, and it is noted that you declared ownership of no chattels. Your wife, however, did declare quite a large quantity of chattels, and of these there remains in the protected area the shoe repair machine and tools about which we wrote yourself and Mrs. Kato on October 31st. These chattels, having been declared by Mrs. Eato, are being regarded as her property and are dealt with in her file. The refund of one per cent wage deductions, which was received by the Custodian on your behalf from the Provincial Government in the amount of \$7.85, was remitted to you by Custodian gheque on February 42. 1943. Sun Life Assurance Company cheque for the sum of \$640.00 was mailed to you from this office on August 17, 1944. This cheque represented full settlement of all claims under your life policy #2031263. Your share of the final distribution of assets of the Royston Savings Association, on the basis of your 25 shares, amounted to \$87.53. From this there was deducted the sum of \$17.96 to settle principal and interest on the loan made to you. This left a balance of \$69.57 which was credited to your account, and which is being remitted to you by the enclosed cheque. It would appear that we have accounted for all the property of every kind light by you in the protected area which vested in the Controllian and in order that you may confirm this and acknowledge the enclosed cheque, we are attaching hereto a stamped, addressed envelope for your convenience in replying.
