

Dear Sirt In your declaration to the Custodian, July 24, 1942, you reported some household effects left in your former residence at Cumberland, B. C. the only articles found in your house that were of sufficient value to warrant the expense of moving were a kitchen range and a heater, which were sold for the net sum of \$2.67. Custodian chaque for this sum, payable to yourself and your wife, is being sent to Mrs. KOJIMA today. On March 19, 1943, we sent you a cheque for \$3.86. This money had been received from the Provincial Government as refund of one per cent wage deductions for 1941. We are enclosing herewith Custodian cheque for the sum of \$63.04. as you requested. This money is proportionate share of the assets of the Royston Saving Association on the basis of 18 shares. Your wife reported at the time of her declaration to the Custodian that you had \$25.00 worth of War Savings Certificates in your possession. These did not come under the control of the Custodian. It would appear that we have accounted for all the property of every kind left by you in the protected area which vested in the Custodian and in order that you may confirm this and acknowledge the cheque, we enclose a stamped, addressed envelope for your convenience in replying. PERSONAL PROPERTY SUMMARY File No. 11828 Re: Kenzo KOJIMA Reg. No. 06385. This man signed a declaration to the Custodian on July 6, 1942. In his declaration he reported some chattels left in his former residence, Cumberland, B. C. Mr. Matt Brown reported that the articles delared by "r. KOJIMA had been found in his former residence but only a heater and a stove which were sold at auction for the net sum of \$2.67 were of sufficient value to warrant the expense of moving. The remainder of the chattels were left in the house and abandoned as valueless. The \$2.67 from the sale of the stove and heater have been credited to the account of Kotane KOJIMA, wife of this man. The sheque 2-67 payable to Kenzo and Kotane KOJIMA is being sent to this couple, by any Quite a large quantity of chattels were declared by Mrs. KOJIMA, these according to the file have all been shipped to herself and her husband. Mrs. KOJIMA in her declaration to the Custodian stated that her husband had \$25.00 in War Savings Certificates in his possession. These did not come under the control of the Custodian. This account has been credited with the sum of \$63.04 as proportionate share of the assets of the Royston Savings Association. On March 19, 1943, we remitted to this man the sum of \$3.86 which had been received from the Provincial Government as refund of one per cent wage deductions for 1941.
