GENERAL SUMMARY

Michiko YAMAMOTO died in Vancouver, B. C. on May 24, 1942, at the age of 23 years. She is survived by her father, Teiso YAMAMOTO, file #4527, and her mother, Matsuye, file #8415, both of whom have now been repatriated to Japan.

The deceased made no declaration to the Custodian and nothing is known of her assets.

(funeral expenses)

In view of the financial circumstances of the parents of the deceased, the B. C. Security Commission agreed to withdraw their claim. The Collector of Institutional Revenue was advised that there was little possibility of the Provincial Board of Health receiving payment of their claim.

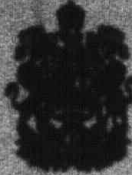
