Enclosed is Custodian cheque for \$64.94, which represents the balance standing to your credit with this office.

These funds are the net proceeds from the sale of an outboard motor, turned over to the Custodian by Naval Service, which was reported to be your property. In your declaration to the Custodian, the only property reported by you was this motor.

On March 19, 1943, we remitted to you the sum of \$9.55, received as refund of wage deductions for 1941.

It would appear that we have accounted for all the property of every kind left by you in the protected area which vested in the Custodian.

This man signed a declaration to the Custodian on July 27, 1942 in which the only thing he reported was a motor engine for a boat in custody at Port Alice, B.C. This engine was turned over to this office for sale and the net proceeds of \$64.94 were credited to the account of this man. This amount is being remitted to him today.

The account of this man was credited with the sum of \$9.55 received as refund of 1 $\frac{1}{2}$ wage deduction for 1941. This was remitted to him on March 19, 1943.
