In your declaration to the Custodian on July 27, 1942, you reported a Champion Ag h.p. engine in custody of the Navy. This engine was sold through this office and the net proceeds of \$24.94 were credited to your account.

You also reported an Evinrude 5 h.p. engine in custody of the Navy. This was taken over by the Nevy and your account was credited with the sum of \$50.00, the appreired value of the engine.

You reported thirteen \$5.00 War Savings Certificates in your own possession. In March, 1943, the sum of \$52.77 was forwarded to you through this office as the redesption value of these Certificates.

You reported a 10-year endowment policy for \$1,000.00 with the Mutual Life Assurance Co. This did not come under the control of this office.
