This file reveals that FUJUI owned no real property in any protected area of B.C. and did not carry any Fire Insurance.

CHATTELS: FURUI made his declaration to the Custodian on Sept. 25/42 and was evacuated on March 19/42. He declared no property of any kind whatsoevel

However Rev. TASHIRO, minister of the Tenrikyo Canada Church, 526 E. Cordova St., declared on Aug. 27/42 that Shichizo FUKUI had stored one b of clothes and misc. and one bed in the church. We inventoried one box and one bed at this address. The contents of the box were sold at auction for the net sum of \$7.11 and this sum credited to his account with the Justodian.

The spring of bed, inventoried by the Custodian, was apparently of no value and was likely discarded ...

We received a letter from FUKUI dated Sept. 8/42 asking us to pay the INSURANCE: premium due on his policy with the Monarch Life Assurance Co.
