GENERAL SUMMARY

File No. 11962

December 11, 1946.

Re: Saburo KOBAYASHI, Reg. No. 063337

This man was evacuated on February 28, 1942. He signed a declaration to the Custodian on August 7, 1943.

The only property declared were the chattels, which were declared also by his wife, Chiyo KOBAYASHI, File 12086. These chattels have been handled in the file of Chiyo KOBAYASHI. Some of the chattels were shipped to Mrs. KOBAYASHI. The saleable items remaining after shipments made were sold for the net sum of \$99.92. As Mrs. Chiyo KOBAYASHI died at Toronto, Ontario on November 14, 1946, and there is no conclusive evidence of individual ownership of the chattels from which the \$99.92 was derived, this sum is being transferred to the account of Saburo KOBAYASHI, and will be remitted to him.
