PERSONAL PROPERTY SUMMARY

May 20, 1946.

Re: Toshio KOTANI, Reg.No.00428

On August 26, 1942, this man signed a declaration to the Custodian stating that he owned no property of any kind in the protected area.

The file reveals that this man owned 5 shares in the Associated Cleaners & Dyers Ltd., File 7822. This company is being liquidated by Mr. Walter A. Jacklin with approval of the shareholders. It is understood that dividends of approximately \$60.00 a share will be paid to the shareholders and that Evacuee shareholders will be paid direct and not through this office.

The wife of Toshio KOTANI, File 13190, sent to this office a receipt given to Torao KOTANI, File 12828, for a Victor radio and record player. As Torao KOTANI has stated that these articles were surrendered on behalf of Toshio KOTANI, we are transferring the net proceeds from the sale of the two items to a joint account to the credit of Mr. & Mrs. Toshio KOTANI, and will forward the funds to Mr. & Mrs. Toshio KOTANI. Net proceeds are \$58.80.
