ASSETS: - On Page 2 of registration dated October 2, 1942 by Gijuro UCHIDA is recorded under "Bank Accounts":-


"Bank of Montreal, Main & Hastings Branch-Joint account with wife, Mrs. Tome UCHIDA".

NOTE: Funds were received from this Bank as July 30/46 and credited to account of Gijuro UCHIDA on our books; amount received \$223.31. This is now being forwarded to him per authority of Mr. Shears October 6, 1947.

LIABILITIES: No indebtedness of Gijuro UCHIDA is declared by him in his registration dated October 2, 1942. However a claim of \$1403.10 was filed by the Provincial Board of Health (St. Joseph Hospital) against him. This was submitted to him October 29/43 but no answer seems to have been received from him in respect to this claim. Subsequently Mr. Shears wrote to the Collector of Institutional Revenue, Vancouver, on the 22nd August 1947. Not receiving a reply as of today Mr. Shears authorized release of funds held in name of Gijuro UCHIDA to UCHIDA.

No other indebtedness is revealed on the file.

The above Summary is certified to be in accordance with the information on file, October 6th, 1947.

In December 1943 we wrote you advising that the above Japanese had no funds which would enable us to take care of the claim of the Provincial Board of Health (St. Joseph's Hospital).

We have recently received the sum of \$223.31, the balance of a bank account. Under our Order-in-Council money of this nature did not vest in the Custodian and was under the control of the owner.

Mr. Uchida has requested that these funds be forwarded to him but this will not be done until the 15th September in case you may wish to contact Mr. Uchida at New Denver and are able to secure his authority for us to pay you this amount.
