EXCERPT FROM LETTER FROM:

J. A. Russell & Co.,

Dated July 4th, 1942.

In my letter to you of the 30th June last I sent you a list of the several Japanese properties and the names of clients for whom I have been acting I trust in co-operation with your Department. On the 4th instant I reported to R. O. Alexander Esq., his File No. 4122 in respect of one of the matters referred to in my letter to you of the 30th June.

It is the 4th matter in my letter to you to which I must again call your attention viz the death of Nubuichi Uyeda and the monies in Court in favour of his Beneficiary an Infant Satochi Yamabe for whom and his natural Guardians his Mother and Father I am acting. Is your Department or the Custodian interested in this matter. It is important I advise the Court of your attitude without delay. The infant and his father are evacuated but his mother importunes me every day to know what is being done about this money so paid into Court.

Please see me or write me on this subject on receipt.

In the meantime have come up such claims as arise out of the death of Nubichi Uyoda who was insured by the British Columbia Mutual Benefit Association in favour of a Japanese infant Satochi Yamabe in the sum of practically \$2500.00. Satochi Yamabe is the named beneficiary, with considerable difficulty I have this money paid into court less insurance company costs of \$15.00 Dominion and Provincial Succession and other duties are established as well as Solicitor and other costs. But the Court says the balance of this money must be held in Court until the boy now about sixteen maintains his majority. Leave however has accorded me to apply on behalf of parties interested or concerned to make further or other application to the Court. In a more or less recent letter from your office it is suggested that monies of this matter are within the control and should be controlled by the Custodian with or without my assistance. I would like very much to talk this matter over with your representative. For the moment I think this money should be accounted for to the Custodian rather than to be held in Court until the boy is of age. In any case some provision should be made out of this money for the boys support and education. Will someone from your office talk this matter over with me on receipt.
