PERSONAL PROPERTY SUMMARY

This file reveals that Mr. YAMAMOTO owned no real property in any protected area of B. C. and did not carry any Fire Insurance.

CHATELS: Although Mr. YAMAMOTO made no declaration to the Custodian we were advised by Mrs. Tomizo ONODERA, File 9952, that some chattels belonging to Mr. YAMAMOTO were stored at her home, 2013 W. 5th Ave.

These were sold at auction for the net sum of \$4.79 and this sum credited to his account with the Custodian. This sum being transferred to the file of the wife as she declared chattels and he did not.

SHARES: An extract from the file of the B. C. Purchasers' Assn. informs us that YAMAMOTO owns 10 shares in that company.
